# Gifts & Hospitality Declarations 2022/23

## 1 Introduction

The Gifts and Hospitality Policy is one of a suite of policies that reinforces the University's financial control. The others being the; Anti-Money Laundering, Anti-Bribery, Counter Fraud and Corruption policies and the Financial Regulations. In addition, the University follows the requirements of the Criminal Finance Act 2017.

The Gifts and Hospitality Policy sets out the conditions under which gifts and hospitality may be accepted by officers of the University and makes it a requirement for all members of the Senior Management Board to make an annual declaration of any gifts or hospitality that they have personally accepted. The policy was last updated June 2022.

## 2 Annual Declarations 2022-23

All members of VCEG individually, and Academic Board members for their reporting areas have made an annual declaration of gifts and hospitality for 2022/23 in accordance with the Gifts & Hospitality Policy.
